**(Excerpt from CdV Bylaws)**

CdV members shall at all times conduct themselves in a manner that is not disrespectful, offensive or generally unacceptable to CdV or its members or sponsors. Examples of behavior in violation of this code include but are not limited to the following:

- Dangerous or illegal activity while wearing CdV clothing.
- Not wearing a helmet while riding a bicycle and either wearing CdV clothing or participating in a CdV activity.
- Making publicly disparaging comments about CdV, a CdV member or a CdV sponsor and/or its products.
- Publicly promoting a direct competitor of a CdV sponsor.
- Harassing a CdV member or sponsor, including, but not limited to, sexual harassment.
- Unauthorized commercial use of CdV email (electronic mail) list.
- Gambling on any bicycle race event in which a CdV member is a participant.
- Colluding with another race team in a manner that is against the best interests of CdV.

Violations of this code shall be deemed to have occurred by majority vote of the Board of Directors and subsequent notice to the offending member.
